C I R C U L A R

Sub: Total disregard to Government orders led to huge inadmissible payment towards HRA of Rs. 1.42 crore - recovery thereof -reg.

Sir/Madam,

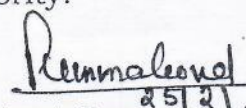
As per this Administration's Circular No. 55-3/2005-PW dated 09.05.2007, all the employees posted in Southern Group of Islands/ Little Andaman has been allowed HRA and also exempt them from payment of License fee, if any, for the shared accommodation until permanent accommodation as per their entitlement are allotted to them.

However, while auditing the accounts of Secretariat Establishment, Audit has pointed out the irregularity that HRA allowed to these employees is in deviation to the Government of India's Order and the competent authority finds that decision turns to be ultra-vires and therefore non-est in law. Accordingly the last 3rd para of the said circular was withdrawn vide this Administration's Circular of even No. dated 15/07/2020. So, to settle the matter and to drop the Audit Para, these excess amount (Rs. 1.42 crore) needs to be recovered from the concerned employee.

Therefore, recovery of inadmissible payment of HIRA made to 296 employees as at Annexure-I (copy enclosed), and those who were allotted shared accommodation from May 2007 onwards, be effected immediately. Further, if the officer/official has been transferred and posted to some other department/office, the same may be forwarded to concerned department for effecting the recovery.

A compliance report should be furnished to this Administration.

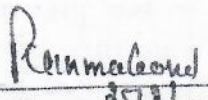
