PRINCIPAL'S MESSAGE ——

It gives me immense pleasure to present the second edition of Nyaya Dweep. The past four months have been marked by vibrant academic, co-curricular, and extension activities, reflecting the college's steadfast commitment to holistic legal education. At Andaman Law College (hereinafter ALC), I firmly believe that education extends beyond classroom instruction, it is a process that blends theory with practice, fostering intellectual growth, professional competence, and social responsibility.

One of the most significant milestones achieved during this period is the establishment of the Free Legal Aid Services Clinic on our campus, in collaboration with the District Legal Services Authority (DLSA). The Clinic offers legal assistance to the people of the Islands, thereby extending access to justice to the under-served. DLSA has appointed an Advocate and a Para-Legal Volunteer to provide services to those in need. As a socially conscious institution, ALC remains committed to enhancing the quality and reach of such community-oriented initiatives.

The Clinic was inaugurated by Hon'ble Mr. Justice Surya Kant, Judge, Supreme Court of India, and Executive Chairman, National Legal Services Authority (NALSA), in the distinguished presence of Hon'ble Mr. Justice Dipankar Bhattacharya, Judge, Supreme Court of India, and Hon'ble Mr. Justice T. S. Sivagnanam, the then Chief Justice of the Calcutta High Court, along with other eminent judges. This occasion marks a landmark in the history of Andaman Law College, as it provides students with a platform to engage directly with real-world legal issues and understand the dynamics of access to justice.

ALC recently organized a National Seminar on "Access to Justice and Rule of Law," which witnessed the gracious presence of Prof. (Dr.) Faizan Mustafa, Vice-Chancellor, Chanakya National Law University, Patna, as the keynote speaker. The deliberations in the seminar brought to light the pressing need for judicial reforms to address the persistent pendency of cases before various courts. The discussions reaffirmed that advocacy is not confined to courtrooms; it encompasses social advocacy and community engagement as well.

For the first time in the history of college, our students visited the District Prison at Prothrapur to observe prison administration and to gain insights into issues concerning correctional facilities and the rights of inmates. Such experiential learning is integral to developing socially sensitive and ethically grounded legal professionals.

Our students have also represented ALC in National Moot Court Competitions across the country, showcasing their advocacy and analytical skills. I extend my heartfelt congratulations to the team that secured Second Place in Memorial Submission among 29 participating institutions in the competition held at Tirupur, Tamil Nadu, and to another team that reached the semi-finals and won the Best Mooter Award at the competition held in Hyderabad, Telangana. Their achievements have enhanced the reputation ALC at the national level.

It was also a matter of pride for ALC designated as the Nodal Institute for the Viksit Bharat Youth Parliament 2026 for the second time. The participation of our students was exemplary, with three of them securing the top three positions in the event in 2025.

The internship programme with the Airports Authority of India (AAI), conducted under our existing Memorandum of Understanding, is progressing successfully. It provides our students with valuable exposure to the functioning of legal systems within public institutions. I am also pleased to note that the fifth consecutive batch (2020–2025) has achieved 100% success in their final semester examinations, an achievement that reflects the dedication of both students and faculty members. Our guiding philosophy is embodied in our motto:

"Dharmo Rakshati Rakshitah" — "The law protects those who uphold it."

We remain deeply committed to empowering, enlightening, and preparing our students for meaningful careers in law and public service. I extend my sincere appreciation to the faculty, staff, and students whose unwavering commitment continues to uphold the values and vision of ALC.

The Clinic is being run by the Andaman Law College in association with the A & N State Legal Services Authority, Sri Vijaya Puram.

The Hon'ble Mr. Justice Surya Kant, Supreme Court of India and Executive Chairman, National Legal Services Authority inaugurated this clinic in presence of Hon'ble Mr. Justice Dipankar Datta, Supreme Court of India. This programme was also attended by the Hon'ble Chief Justice of Calcutta High Court Justice T.S. Sivagnanam and a galaxy judge from Calcutta High Court.

One Advocate is designated by the Legal Services Authority will render services on a regular basis through this Clinic. Faculty in-charge Andaman Law College assisted by the students of Law will help, assist and monitor the Clinic in delivering goods to the needy to render legal aid and related services. Good collections of Bare Acts, Books were placed in the Clinic and one computer system also placed there.

Now, Andaman Nicobar Islands find a place in the list of National Legal Services Clinics network of NLSA, New Delhi.

It will go a long-way in helping the underprivileged translating the ideals enshrined under Article 39 (A) of Indian Constitution.

INTERNSHIP COLLABORATION WITH AIRPORT AUTHORITY OF INDIA

For the first time since its inception, Andaman College (ALC) has entered into a formal collaboration with the Airport Authority of India (AAI) to facilitate an internship program for its law students. A Memorandum of Understanding (MoU) was signed between the institutions, which will remain valid for a period of five years.



Through this initiative, students of the fourth and fifth years of the B.A. LL.B. (Five Year Integrated Programme) will have the opportunity to undertake internships at the local international airport, gaining firsthand exposure to the operational, regulatory, and legal dimensions of airport management. This partnership is a milestone achievement for the College and is expected to strengthen the practical learning component of legal education while promoting interaction between academia and industry. The continuous internship program will also provide students with a broader understanding of public administration, transport regulation, and legal compliance in the aviation sector.

IGNOU STUDY CENTRE

Andaman Law College has received approval from the competent authority to establish an IGNOU Study Centre offering law-related programs. The draft MoU has been sent to the IGNOU Central Office for final approval and signature by the Registrar. The Centre is proposed to begin functioning from the next academic month and will enroll students from and across all higher education institution including those of ALC and non-student youth and local residents interested in pursuing law and allied subjects through the distance mode of education.

ALC @ NATIONAL UNITY DAY

ALC SEEKS INDIAN LAW INSTITUTE (ILI) INSTITUTIONAL MEMBERSHIP

On the kind recommendation of Hon'ble Justice Surya Kant, Judge, Supreme Court of India, Andaman Law College has applied for Institutional Membership with the Indian Law Institute (ILI), a premier legal institution, situated at New Delhi.

This association, once approved, will greatly enhance the College's academic and research capabilities by providing access to legal databases, research journals, and digital resources available through ILI. The membership will facilitate intellectual exchange and professional networking, bridging the gap between mainland legal institutions and the college located in the islands. It will also encourage collaborative research, internships, and exposure to contemporary developments in law and jurisprudence.

CONSUMER ADVOCACY GROUP FORMED

A Consumer Advocacy Group was formed at Andaman Law College, consisting of around 80 students from the 4th and 5th years. The group is now part of the National Consumer Advocacy Network.

The initiative reflects ALC's commitment to social justice and community engagement by promoting consumer rights awareness across the Andaman and Nicobar Islands. The group undertakes activities aimed at spreading legal literacy, assisting consumers in understanding their rights, and advocating ethical business practices as a civic duty. This aligns with the broader vision of the institution to inculcate a sense of responsibility among its students toward society and governance.

CERTIFICATE COURSE IN "CRIMINOLOGY PROFILING AND FORENSIC FUSION"

A total of 16 final-year students successfully participated Certificate Course on "Criminology **Profiling** and Forensic conducted on 23rd August 2025. The course aimed to integrate theoretical knowledge with practical exposure to modern forensic techniques criminal profiling. It enabled students to understand the interplay between law enforcement, psychology, and forensic science, thereby enriching their academic learning and preparing them for careers in criminal law and investigation.

TUBERCULOSIS AWARENESS PROGRAMME



An Awareness Programme on Tuberculosis (TB) was held at the College on 23rd August 2025 in collaboration with the Government TB Control Unit, Andaman & Nicobar Islands.

The session focused on the prevention, symptoms, and treatment of TB and emphasized the role of youth in promoting public health awareness. The event reinforced the College's engagement with broader health education initiatives in the community.

The programme saw active participation from 75 students, faculty members, and administrative staff. Discussions centered on data protection, cybercrime prevention, and the legal implications of emerging technologies. The highly interactive session emphasized the importance of digital ethics and cyber literacy for law students.

For the first time in the history of the institution, ALC organized a four-day educational visit to the District Prison, Prothrapur, Sri Vijaya Puram, with necessary permissions from the prison authorities.

Students from the 2nd, 3rd, 4th, and 5th years participated in the program between 8th and 11th September 2025. The visits offered a valuable opportunity to understand the functioning of prison administration, correctional measures, and rehabilitation programmes.

The initiative provided students with real-world exposure to the criminal justice system, bridging the gap between theoretical learning and practical realities.




TRAFFIC AWARENESS PROGRAMME


