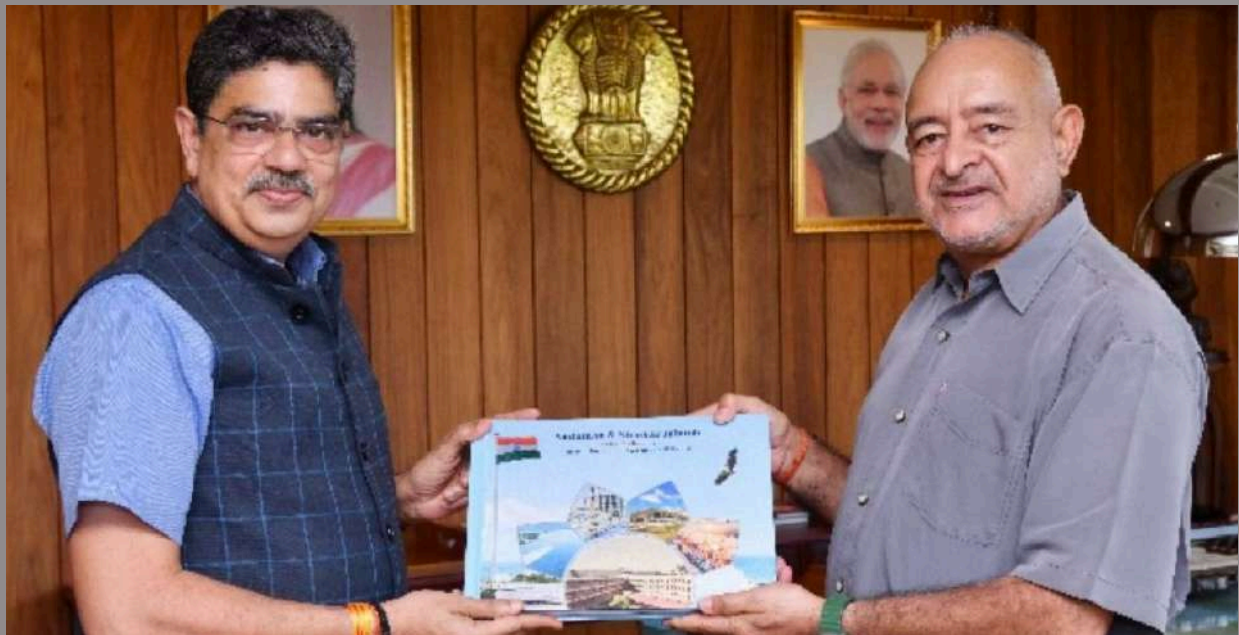

The year 2026 marks a milestone in the history of Andaman Law College on multiple fronts. Firstly, the institution completes a decade of its credible presence among the centres of legal education in the country. Secondly, it has been elevated to the status of a constituent college of Netaji Subhash Chandra Bose Institute of Higher Learning (NSCBIHL). Thirdly, as a mark with this development, the College has upgraded its academic programme from B.A. LL.B. to B.A. LL.B. (Hons.).

This upgraded programme is not just merely an honours in words, but reflects a forward-looking comprehensive curriculum that is contemporary, relevant and region-specific. Maritime Law, Law relating to Tourism and Disaster Management etc. have been incorporated to catch national trends.

The first Board of Studies meeting, held on 28th April 2026, approved the Academic Regulations for the B.A. LL.B. (Hons.) Five-Year Integrated Programme. The framework has been designed in conformity with the Bar Council of India, Rules of Legal Education, 2008, and the National Education Policy 2020 guidelines.

In its endeavour to bridge the gap with premier mainland institutions, Andaman Law College has signed Memoranda of Understanding (MoUs) with the Damodaram Sanjivayya National Law University, Visakhapatnam, Andhra Pradesh, and the PRIST University School of Law, Tamil Nadu, for academic collaboration and legal research. An MoU is under active consideration with the Indian Maritime University, Chennai to collaborate in the specialised areas of Maritime Law and Logistics. Additionally, an MoU has already been signed with Indira Gandhi National Open University, and the College is presently awaiting clearance from the Registrar, IGNOU, New Delhi, to establish a 'Learner Support Centre' to offer law-related programmes.

The College has recorded noteworthy achievements in the first quarter of 2026. Three teams represented the Andaman & Nicobar Islands at New Delhi in the prestigious national-level Viksit Bharat Youth Parliament (2025 and also in 2026). A student from this College participated in the National Integrity Day held at Parliament Bhavan, New Delhi. Further, a four-member team took part in the National Youth Dialogue "*My Bharat Budget Quest 2026*" held in Bhubaneswar, Odisha.

The College also marked its presence at the IDE Bootcamp Edition III (Phase I) held at DBRAIT, Sri Vijaya Puram, where two teams of law students presented innovative ideas and prototypes before a panel of industry experts, an achievement particularly significant as it marked the first-ever participation of law students in the event.

Guided by our enduring motto, "Dharmo Rakshati Rakshitah," the College remains steadfast in its commitment to academic excellence, integrity, and inclusivity. We continue to strive towards nurturing competent legal professionals equipped to meet the evolving challenges of society. I wish all the best for the upcoming end semester examinations. I am sure that my final year students of 2026 will repeat 100 percent pass like earlier batch of 2025 students.

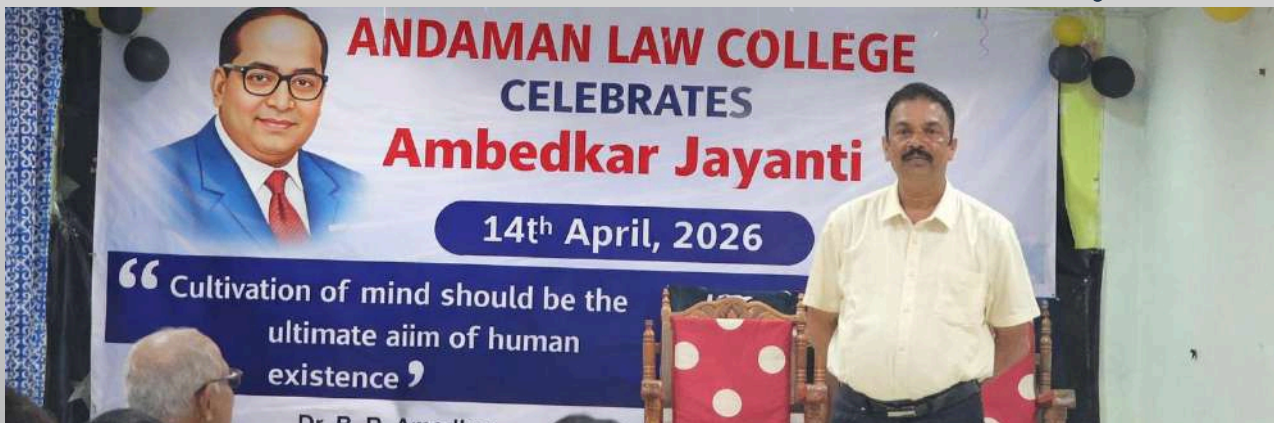

ALC @ Parakram Diwas

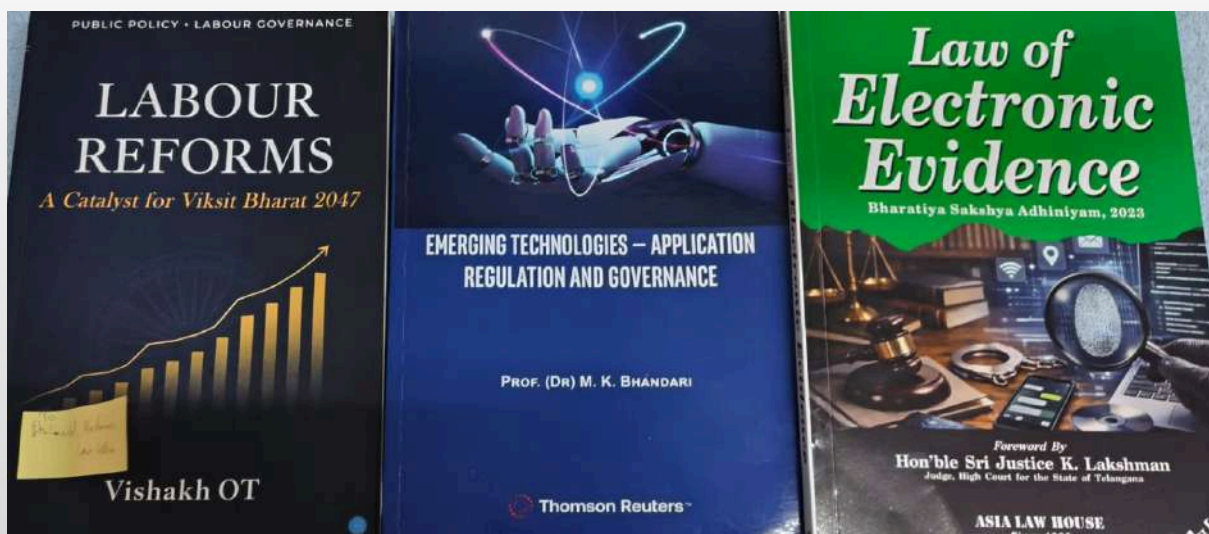

LIST OF DOCTRINES

1. **Ejusdem Generis** – Means of the same kind. (Article 12)
2. **Ab Initio** – Means for the very beginning. (Article 13)
3. **Doctrine of Judicial Review** – A law is declared unconstitutional by the Supreme Court or High Court if it contravenes any of the Fundamental Rights. (Articles 13, 32, 226)
4. **Doctrine of Eclipse** – The law which contravenes Fundamental Rights is not void ab initio; it remains in a morbid condition and unenforceable. It is not totally wiped out from the statute book. (Article 13)
5. **Doctrine of Severability** – The whole law is not void under Article 13; only that portion which contravenes Fundamental Rights is void, and the rest remains operative. (Article 13)
6. **Doctrine of Rule of Law** – It means supremacy of law and absence of arbitrary power. (Article 14)
7. **Principle of Reasonable Classification** – Equals cannot be treated unequally and unequals cannot be treated equally. (Article 14)
8. **Audi Alteram Partem** – Means no one should be condemned unheard. (Articles 14, 21, 22)
9. **Wednesbury Principle** – Used to adjudge the discretion provided to the executive under the statute. (Article 14)
10. **Lex Non a Rege Est Violanda** – Means the law must not be violated even by the king. (Article 14)
11. **Pari Passu** – Means on equal footing. (Article 14)
12. **Rex Quod Injustum Est Facere Non Potest** – Means the king cannot do what is unjust. (Article 14)
13. **Principle of Proportionality of Restrictions** – Restrictions should not be arbitrary or beyond what is required for achieving the object. (Article 19)
14. **Ex Post Facto** – A law which imposes penalty retrospectively. (Article 20)
15. **Double Jeopardy** – No person shall be prosecuted and punished for the same offence more than once. (Article 20)
16. **Nemo Debet Bis Vexari Pro Una et Eadem Causa** – Means a man shall not be vexed twice for one and the same cause. (Article 20)
17. **Nemobis Punitur Pro Eodem Delicto** – Means no one can be punished twice for the same offence. (Article 20)
18. **Autrefois Convict** – Refers to a defendant's plea that he has already been tried and convicted for the same offence. (Article 20)
19. **Nova Constitutio Futuris Formam Imponere Debet, Non Praeteritis** – Means a new law ought to be prospective and not retrospective in operation. (Article 20)
20. **Doctrine of Self-Incrimination** – No person accused of any offence shall be compelled to be a witness against himself. (Article 20)

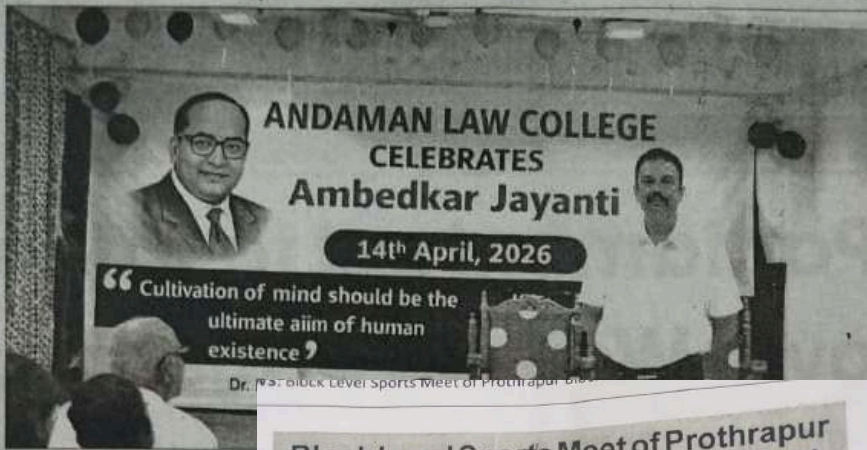

ANYONE CAN HARM, EVERYONE CAN PROTECT: THE HIDDEN REALITY OF CHILD ABUSE IN INDIA

February 2, 2026

Childhood exploitation, harassment, and sexual abuse persist as a serious yet frequently concealed issue across India. Abusers are not confined to strangers or a single gender. Men, women, older adolescents, and family members can all perpetrate harm. The problem lies not in gender but in the exploitation of power, trust, and opportunity to target a vulnerable child. No group is inherently safe or dangerous; any individual can choose to cause harm. Equally, every adult and community member has the capacity to safeguard children.

Abuse manifests in multiple, often overlapping forms. Sexual abuse encompasses unwanted touching, forced sexual acts, exposure to pornography, or involvement in explicit content. Criminal exploitation compels children into drug trafficking, theft, or gang-related activities. Labour exploitation imposes unpaid or hazardous work in agriculture, shops, or begging. Trafficking relocates children for sexual or economic gain. Psychological and emotional abuse includes persistent criticism, humiliation, or emotional neglect that undermines self-worth. Physical abuse involves hitting, burning, or other bodily harm. Neglect fails to provide essential needs such as food, medical care, education, or emotional support. Bullying, both in person and online, entails threats, humiliation, or sharing harmful images. Witnessing domestic violence exposes children to repeated aggression and fear within the home.

These forms inflict comparable long-term damage to brain development, emotional stability, physical health, and future opportunities.

Most abusers are individuals known to the child.
