\*The Secretary (RD/PRI) is a member of the Establishment Board and Hard Case Committee when the Board considers transfer and posting between APWD and depts. of RD/PRI's.

The Board shall function as per the following guidelines:-

1. The board shall propose transfer/posting of Group "A" & "B" (Gazetted) officers of the APWD as per the transfer policy formulated for technical staff.
2. The Establishment Board shall put up transfer/posting of the Group "B (Gazette) & A" officers to the competent authority for approval.
3. Reasons for disagreement with the posting and transfer proposal made by the Board may be recorded.
4. Representations against the transfer /posting orders in PWD if any shall be submitted to the Hard Case Committee. The Hard Case Committee shall examine such representations and submit their recommendations to the Chief Secretary, A&N Administration for a decision.
5. Representations against the transfer/posting orders, if any submitted by the PWD Engineering officials posted at RD/PRI, the committee shall examine such representations and submit their recommendations to HLG separately for approval.
