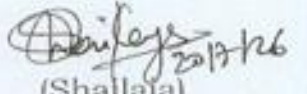
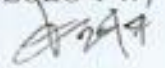
On their promotion to the post of Head Clerk/Assistant In-charge/Assistant, they are entitled to exercise an option to get their pay fixed in the promotional post in accordance with the provisions contained under the Saving Clause of FR 22(1)(a)(1). The option shall be exercised within one month from the date of reporting to the promoted post and the option once exercised shall be final.



In case their pay has already been fixed under MACP Scheme under the provisions of FR 22(1)(a)(1), no further pay fixation benefit shall be accrued to them in terms of condition-4(ii) of Annexure I of the Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training), New Delhi's OM No.35034/3/2015-Estt(D) dated 22/10/2019.

In respect of matters not specified above, they will be governed by the rules and orders issued by the Govt. of India from time to time in respect of officials of their category working under the A&N Administration.

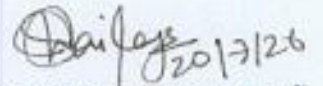
