In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi Notification No. 14/3/60-ANL dated 11th April 1960 and in modification of the Notification No.295/2010/F.No.14/Estt/DA/2007(Agri) dated13.09.2010. Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby proposes to make the following rules regulating the method of recruitment to the post Group 'C' post of Assistant Chargeman borne Department of Agriculture, Andaman and Administration, namely :-

Objections and suggestions are invited from the stake holders/persons to be affected thereby. The objection and suggestions(if any) should reach the office of the Director of Agriculture, A&N Administration within 30 days from the date of publication for consideration.

1. Short Title and Commencement:-

- i. These Rules may be called the Andaman and Nicobar Administration (Group 'C') post of **Assistant Chargeman** in the Department of Agriculture, Recruitment Rules, 2023.
- ii. They shall come into force on the date of their publication in the official Gazette.
- 2. Number of posts, Classification and Scale of Pay: The number of post, its classification and the scale of pay attached thereto shall be specified in paras 2 to 4 of the Schedule annexed thereto.
- 3. Method of Recruitment, Age Limit and Other Qualification:
 The method of recruitment, age limit, qualification, duties & responsibilities and other matters relating to the said post shall be as specified in Paras 5 to 13 of the above said Schedules.
- 4. Disqualification No Person -

- a. Who has enter into or contracted a marriage with a person having a spouse living, or
- b. Who having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Lieutenant Governor, Andaman and Nicobar Islands may, if satisfied that such marriage is permissible under the personnel law applicable to such persons and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of this Rules.

5. Power to Relax :-

Where the Lieutenant Governor, Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing relax any of the provisions of these rules with respect of any class or category of persons.

6. Savings :-

Nothing in these rules shall effect the reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Annexure to Schedule

Job description for the post of Assistant Chargeman (Pay Level -4)

1. They will be responsible for carrying out the repairs and maintenance of all types of vehicles/agriculture equipments of the Department of Agriculture.

- They will have to work under the technical and over all guidance of the Agriculture Engineering Assistant and Chargeman for execution of repair and maintenance of vehicles.
- They will have to work out whether any spare parts and related materials are required to carry out the maintenance/repairs works and report the same to the Agriculture Engineering Assistant and Chargeman for making arrangements for procurement.

 Routine inspection of the vehicles and overhauling of vehicles as and when required.

- They should be in constant touch with the Agriculture Engineering Assistant and Chargeman when a vehicle is put into garage for repair/ maintenance.
- They will carry out at the instructions/orders issued by their superiors.
- 7. The other works as assigned by the superiors.
