No......./F.No.2-236/IP&T/2018-Group-'C' Tourism, in exercise of the powers conferred by the proviso to Article 309 of the constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No.14/3/60-ANL dated 11.04.1960, and in pursuance of DOPT's OM No.AB-14017/13/2013-Estt.(RR) dt. 31.03.2015 and OM No. AB.14017/13/2016-Estt.(RR) dated 09.08.2016 the Lieutenant Governor (Administrator), Andaman & Nicobar Islands, hereby makes the following amendments to the Recruitment Rules to Group-'C' Post of Helper-Cum-Kitchen Steward of Department of Information Publicity and Tourism, Andaman & Nicobar Administration published in the A & N Extraordinary Gazette Notification No.47/2001/ F.No.10-24/38-Pty, dt.09.03.2001.

#### 1. SHORT TITLE AND COMMENCEMENT:

- i). These Rules may be called the Union Territory of Andaman and Nicobar Islands (Group-'C' Non-Gazetted) Recruitment (Amendment) Rules, 2019.
- ii). They shall come into force on the date of their publication in the Official Gazette.

### **AMENDMENTS**

2. i). The existing entries against Column-4 of the Schedule –I appended to the Recruitment Rules (therein after called for brevity as the "said Recruitment Rules") shall be substituted as under:
