No....../F.No.42-517/2017-TR(PF), In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs, New Delhi Notification No.14/3/60-ANL dated 11.04.1960 and in partial modification of this Administration's Notification No. 92/2011/F.No.42-517/2006-TR(2) dated 18.03.2011 and No. 259/2018/F.No.42-517/2017-TR(PF) dated 17.07.2018, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following rules regulating the method of recruitment to the Group 'C' (Non-Gazetted) (Non-Ministerial) post of **Welder** in the Directorate of Shipping Services, Andaman and Nicobar Administration, namely:-

1. SHORT TITLE AND COMMENCEMENT:

- (i) These Rules may be called the Andaman & Nicobar Administration (Welder in the Directorate of Shipping Services) Recruitment Rules, 2020.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

2. NUMBER OF POSTS, CLASSIFICATION AND SCALE OF PAY:

The number of posts, their classification and scale of pay attached thereto shall be as specified in para 2 to 4 of the Schedule annexed hereto.

3. METHOD OF RECRUTIMENT, AGE LIMIT AND QUALIFICATIONS:

The method of recruitment, age limit, qualifications and other matter relating to the said posts shall be specified in paras 5 to 13 of the said Schedule.

4. DISQUALIFICATION:

No Person-

(a) Who has entered into or contracted marriage with a person having a spouse living, or

(b) Who, having a spouse living, has entered into or contracted a marriage with any person,

Shall be eligible for appointment to the said posts:

Provided that the Lieutenant Governor (Administrator), Andaman and Nicobar Islands may, if satisfied, that such marriage is permissible under the personal law applicable to such persons and other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

1. POWERS TO RELAX:

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provision of these rules with respect to any class or category of persons.

2. SAVINGS:

Nothing in these rules shall effect reservation, relaxation of age limit and other concessions required to be provided for candidates belonging to Scheduled Caste, Scheduled Tribe and other specified categories of persons in accordance with the Orders issued by the Central Government from time to time in this regard.
