DRAFT NOTIFICATION

No. /F. No. 6-1(8)/2022– In exercise of powers conferred by the proviso to Article 309 of the Constitution of India, read with the Govt. of India, Ministry of Home Affairs, New Delhi, Notification No. U-14939/2/83-ANL dated 21st February, 1985 and in Supersession of Administration's Notification No.103/2013/F.No.6-1(8)/2011-MPH dated 24th May, 2013, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands hereby makes the following Rules regulating the method of recruitment to Group 'B' (Non-Gazetted / Non-Ministerial) Posts of **Psychiatric Social Worker** borne in the establishment of Directorate of Health Services, Andaman and Nicobar Administration, namely:-

1. Short Title and Commencement:-

- (i) These Rules may be called the Andaman and Nicobar Administration Group-'B' (Non-Gazetted/Non Ministerial) Post of **Psychiatric Social Worker** in the Directorate of Health Services Recruitment Rules, 2023.
- (ii) This shall come into force on the date of its publication in the Official Gazette.

2. Number of Posts, Classification and Scale of Pay:-

The number of Posts, Classification and the scale of pay attached thereto, shall be as specified in Column 2 to 4 of the Schedule annexed thereto.

3. Method of Recruitment, Age Limit and Other Qualification:-

The method of recruitment, age limit, educational qualifications and other matters relating to the said posts shall be as specified in Column 5 to 13 of the attached schedules.

4. Initial Constitution of the service:-

The **Psychiatric Social Worker** working under the Health Department of this Administration as on the date of publication of this rules in the Official Gazette, their services shall be deemed to have been appointed under these rules and they shall be members of the service.

5. Disqualification:-

No person-

(a) Who has entered into or contracted a marriage with any person having a spouse living.

OR

(b) Who, having a spouse living, has entered into or contracted a marriage with any person; shall be eligible for appointment to the said posts:

Provided that the Lieutenant Governor (Administration), Andaman and Nicobar Islands, may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and there are other grounds for so doing, exempt any person from the provision of these rules.

6. Powers to Relax:-

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands, is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

1. Saving:-

Nothing is these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
