No..... eFile No. 31413-A/221/2023-Confidential-AGRI-AGRI_AN - In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi Notification No. 14/3/60-ANL dated 11th April 1960 and in supersession to all previous notifications for the post mentioned below, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby proposes to make the following rules regulating the method of recruitment to the Group 'C' post of **Surveyor** borne in the Department of Agriculture, Andaman and Nicobar Administration.

Objections and suggestions (if any) may be submitted to the Office of Director of Agriculture, A&N Administration, Haddo, Port Blair within a period of 30 days for consideration.

1. Short Title and Commencement:-

- i. These Rules may be called the Andaman and Nicobar Administration Group 'C' post of **Surveyor** in the Department of Agriculture, Recruitment Rules, 2023.
- ii. They shall come into force on the date of their publication in the official Gazette.

2. Number of posts, Classification and Scale of Pay: -

The number of post, its classification and the scale of pay attached thereto shall be specified in paras 2 to 4 of the Schedule annexed thereto.

3. Method of Recruitment, Age Limit and Other Qualification :-

The method of recruitment, age limit, qualification, duties & responsibilities and other matters relating to the said post shall be as specified in Paras 5 to 13 of the above said Schedules.

4. Disqualification

No Person -

- a. Who has entered into or contracted a marriage with a person having a spouse living, or
- b. Who having a spouse living has entered into or contracted a

marriage with any person, shall be eligible for appointment to the said post.

Provided that the Lieutenant Governor, Andaman and Nicobar Islands may, if satisfied that such marriage is permissible under the personnel law applicable to such persons and the other party to the marriage and there are other grounds for so doing exempt any person from the operation of this Rules.

5. Power to Relax :-

Where the Lieutenant Governor, Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing relax any of the provisions of these rules with respect of any class or category of persons.

6. Savings :-

Nothing in these rules shall effect the reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

3. To carry out any other work entrusted to him by Assistant Director (Agriculture Engineering) from time to time in connection with any urgency.
4. Any other works as assigned by the superiors.
