- 2. Candidates must ensure that they are fully aware of the physical risks evolved in the trade test and voluntarily agrees to participate, taking full responsibility for their own health and safety.
- 3. Candidates must carry at least one original valid Photo-ID proof having the date of birth, photo-bearing Aadhaar Card/ Printout of E-Aadhaar, Voter's ID Card, Driving License, PAN Card, Passport, ID Card issued by University/ College/ School, Employer ID Card (Govt./ PSU), Any other photo bearing ID card issued by the Central/ State Government during the Trade Test. Attested copies, scanned copies, or digital versions on mobile phones will not be accepted as valid ID proof.
- 4. Candidates are also requested to bring Educational Certificate / Experience Certificate, if any, during the trade test with regard to trade opted by them.
