- Identification of Talent pool and talent development for attainment of high levels of performance in sports.
- ii. To train minimum 30 trainee under respective Centre and to motivate them
- iii. Producing personalized training programmes.

- iv. Maintaining records of trainees' performance, evaluation, skills and fitness.
- v. Coordinating trainees' attendance at meetings and other sports events.
- vi. Planning and running programmes of activities for groups and individuals that will enable athletes to achieve maximum performance.
- vii. Finding appropriate competitions for participants.
- viii. Planning work schedule in consultation with the competent authority / Director (S&YA)/KIC.
- ix. Ensuring to submit detail evaluation report of trainee's performances (monthly) to the Director (S&YA)/KIC/Department of S&YA Office.
- Any other assignments/work allocated by the competent authority.

#### 5. Performance Management:

Evaluating performance and providing suitable feedback, balancing criticism with positivity and motivation. Assessing strengths and weaknesses in an athlete's performance and identifying areas for further development.

- Adapting to the needs and interests of group or individual trainees.
- ii. Communicating instructions and commands using clear, simple language.
- Encouraging participants to gain and develop skills, knowledge and techniques.
- iv. Ensuring that trainees train and perform to a high standard of health and safety at all times.
- v. Inspiring confidence and self-belief.
- vi. Acting as a role model, gaining the respect and trust of the people.
- Liaising with other partners in performance management, such as Coaches, Physiotherapists, Doctors and Nutritionists.
- viii. Working to a high legal and ethical standard at all times, particularly in relation to issues such as child safeguarding gender equality and health and safety requirements including protection from sexual harassment.

#### **GENERAL CONDITIONS:**

- Tenure: The contractual engagement will be for a period of one (1) year, it may further increase on the basis of satisfactory performance, periodic reviews, result oriented, etc. and at all times coterminous with the Khelo India Scheme.
- 2) Other Allowances: No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible.
- Leave: Engaged candidate will be entitled for 2½ days per month. There shall be no leave encashment against the unveiled leave.

#### 4) Other Conditions:

a) The applications received will be scrutinized and shortlisted on the basis of eligibility-criteria mentioned herein above and the eligible candidates will be called for Interview at cost to the applicant.
