Subject: Proposal for DPC to consider eligible feeder grade officers for induction to the Entry Grade of DANICS for the vacancy year 2025 -reg.

Sir,

I am directed to refer to this Ministry's letter of even number dated 02.01.2025 and consequent reminders dated 18.03.2025, 14.08.2025 and 02.09.2025, DO letter of even number dated 27.03.2025 and its consequent reminders dated 22.04.2025 and 13.05.2025 (Copy enclosed) vide which this Ministry had sought the seniority list of 200 eligible and willing officers for induction to Entry Grade of DANICS for VY 2025. Further, the necessary information/documents i.r.o. 63 seniormost willing officers of GNCTD and willing SC/ST/PwBD officers (b/w seniority position of 64 to 200 in the aforementioned seniority list) were also sought from GNCTD. However, as on date the aforesaid information/documents are still awaited from GNCTD.

2. It is pertinent to mention here that the process of induction to DANICS for VY 2025 is pending with this Ministry, for the want of information/documents of eligible and willing feeder grade officer of DANICS from GNCTD alone. This undue delay is the sole reason for denying the eligible officers, their right for consideration for promotion to DANICS.

3. Accordingly, Govt. of NCT of Delhi is directed to strictly follow the below mentioned instructions for timely completion of process of Induction to DANICS for VY 2025:

- (a) The process of Induction into DANICS & DPC for Senior Scale Group 'A' posts in GNCTD may not be clubbed together & the willingness may be sought from all the eligible Grade-I DSS officers of GNCTD for induction into DANICS by 15.09.2025 as the last date.
- (b) It should be strictly conveyed to the eligible Grade-I officers, that no willingness will be accepted after 15.09.2025. Also, in case of willingness not received from the eligible officer till the stipulated date, he/she will be deemed as "Non-willing" for induction to DANICS for VY 2025 & no further extension for seeking willingness will be provided after 15.09.2025.
- (c) Upon consolidating the status of willingness from the eligible Grade-I DSS officer received till 15.09.2025, Services Department of GNCTD will furnish a seniority list of 200 eligible and willing officers to this Ministry, strictly by 16.09.2025.

(f) Further, the complete documents in respect of 63 senior-most willing officers of GNCTD and information/documents of willing SC/ST/PwBD officers (b/w seniority position of 64 to 200 in the aforesaid seniority list) will be furnished to this Ministry, latest by 24.09.2025.

(g) In case of non-availability of APAR/ACR dossiers with GNCTD as those are already submitted to UPSC, Services Department of GNCTD may furnish an attested copy of APAR/ACR gradings of all eligible and willing Grade-I DSS officers in the prescribed proforma as per Annexure attached. APAR/ACR dossiers of eligible and willing officers may be furnished at a later date.

4. It may also be ensured that the interim stay on the DPC to be held by UPSC on the contested Senior Scale posts in GNCTDSS, should not become a reason for delay in the process of Induction to DANICS for VY 2025.

5. Therefore, Govt. of NCT of Delhi is advised to strictly follow the aforesaid timeline for completion of the process of Induction to DANICS for VY 2025.

6. This issues with the approval of the Competent Authority.
