**EMPLOYMENT NOTICE**

Online applications are invited from Indian Citizens possessing requisite qualifications for appointment to the 01 (One) vacant post of Stenographer/P.A. in the establishment of the Circuit Bench of Calcutta High Court at Port Blair, Andaman & Nicobar Islands.

The appointment will initially be made purely on temporary basis, but is likely to be made permanent.

Eligible candidates may apply online through the website '<https://erecruitment.andaman.gov.in>' OR the e-Recruitment link in the website '<https://www.andamannicobar.gov.in>' giving all the requisite particulars and documents as per the instructions given for filing online application.

Only complete applications submitted through online with all requisite details and supporting documents will be considered. Incomplete applications/unsigned applications/applications submitted without requisite documents/applications uploaded after due date/time will be summarily rejected.

Only the Scheduled Caste category candidates of the Union Territory of Andaman & Nicobar Islands and the State of West Bengal are eligible to apply.

Candidates should upload their Caste Certificate as obtained from the competent authority.

The benefits of separate reservation and age relaxation for the candidates with disabilities (blindness/low vision/other disabilities) will not be admissible as the notified vacancy is reserved only for Scheduled Caste candidates.

Candidates already in service under the High Court, other Courts and Government/Public Sector Undertakings must upload the 'No Objection Certificate' obtained from his/her employer mentioning initial date of joining.

Mode of Selection:

Candidates whose applications are found in order and complete in all respect shall be required to undergo competitive Test in Shorthand and Typewriting on Computer (both in English) followed by Interview. The Shorthand and Typewriting Test shall be held in the following manner:

- i. Dictation: 05 minutes [*@ 120 Words Per Minute*]
- ii. Correction by Candidate: 10 minutes
- iii. Typewriting on Computer (Transcription): 20 minutes [*@ 30 Words Per Minute*]

Candidates shortlisted on the basis of the result of the Shorthand and Typewriting Test shall be required to appear in the Interview.

The marks for the Test / Interview shall be as under:

- i. Marks for Dictation and Typewriting (Transcription): 600 Marks
- ii. Marks for Interview: 10 Marks
- iii. Total Marks: 610 Marks

On the basis of the marks obtained by the candidates, a panel of selected candidates shall be prepared and the same shall stand lapsed on expiry of one year from the date of its notification or on filling up the notified vacancies, whichever is earlier.



The Test and the Interview shall be held at Port Blair on different dates. Information regarding the venue, date and time of the Test / Interview will be notified in due course.

Candidates called for Test/Interview shall be required to appear at the venue at their own expenses and no TA/DA shall be admissible to any of the candidates.

Candidates must bring their Admit Card and at least one original valid Photo Identity Proof documents viz., Passport, PAN Card, Voter Identity Card, Aadhaar Card, Driving License (along with a photocopy thereof) to the Test/Interview venue for verification. This condition is mandatory and in case of failure, candidate will not be allowed to appear at the Test/Interview.

Admit Cards will be generated online.

Once appointed, the matter regarding service, seniority, promotion etc. shall be regulated by the Rules applicable to the Circuit Bench of Calcutta High Court at Port Blair.

In case of any dispute, the decision of The Hon'ble the Chief Justice shall be final.

Applications for the notified post of Stenographer/P.A. in the establishment of the Circuit Bench of Calcutta High Court at Port Blair, Andaman & Nicobar Islands must be submitted online **from 1<sup>st</sup> DECEMBER 2025 (06.00 HOURS) till 31<sup>st</sup> DECEMBER 2025 (23.00 HOURS)** through the website <<https://erecruitment.andaman.gov.in>> OR the e-Recruitment link in the website <<https://www.andamannicobar.gov.in>> upon providing all requisite particulars and documents as per the instructions given for filing the online application.
