Pattern of assistance
50% subsidy of the unit cost for General Fisher / Unemployed Youth / Local Entrepreneur / Fisheries Cooperative Societies and 75% subsidy of the unit cost for Schedule Tribe / Tribal Cooperative Society of A&N Islands.
Eligibility Criteria: Applicant should be a Bonafide fisher / Schedule Tribe / Local unemployed youth / Interested Entrepreneurs / Fisher Coop. Societies / Federation / Tribe Coop. Societies of A & N Islands.



II. Criterion for selection of beneficiaries

1. Bonafide Fisher / Schedule Tribe / Local unemployed youth / Interested Entrepreneurs / Fisher Coop. Societies / Federation / Tribal Coop. Societies of A&N Islands.
 - Bonafide Fisher should produce Fisher Identity Card issued by Authorized Officer of A&N Islands for at-least last two years.
 - Schedule Tribe to produce Schedule Tribe Certificate issued by competent authority of A & N Administration.
 - In the case of Local unemployed youth evidence of 10 years continuous residence in the Islands / Islander Card from competent authority alongwith copy of Aadhaar Card and Registration Certificate of the Firm in case of entrepreneur shall be produced alongwith Copy of Aadhaar Card of Owner of firm.
 - Primary Fisheries Cooperative Societies / Federation / Tribal Coop. Societies to produce copy of Registration Certificate of the Society issued by Registrar of Cooperative Societies, A&N Islands alongwith audited statement of account of last financial year and resolution for availing subsidy.
2. The Bonafide Fisher / Schedule Tribe / Local unemployed youth / Interested Entrepreneurs should be in possession of Aadhaar Card and Bank account.
3. The applicant should submit the application in the format prescribed by the Department.
4. The subsidy shall be admissible for construction of only one boat for each selected beneficiary. In case of applications received from an individual and his / her spouse only one eligible application will be considered.
5. The applicant should not have availed assistance for similar purpose from any Govt. agency in the past five years.
6. The subsidy shall be released only after successful completion of construction of boat based on the recommendations of Fishing Boat Inspection & Assessment Committee constituted by the Department for the purpose within the time frame prescribed by the scheme implementing agency.
7. The subsidy shall be released to the beneficiary through e-Payment in his Bank account under Director Benefit Transfer. In the event of availing of loan for the construction of the boat, subsidy amount shall be routed through the Financing Bank.
8. The Selection of beneficiaries and recommendation of admissible subsidy as per the criterion for selection shall be done by a committee comprising of the following members for all the areas i.e. Municipal area, Zilla Parishads, South Andaman, North & Middle Andaman and Tribal areas of Nicobar District.

- i) Secretary (Fisheries), A&N Administration – Chairman
- ii) Chief Executive Officer, Zilla Parishad, South Andaman / North & Middle Andaman – Member
- iii) Deputy Commissioner, South Andaman / North & Middle / Nicobars or his representative. – Member
- iv) Director of Fisheries, A&N Islands – Member Convener

The terms of reference of the committee shall be:-

- a) Scrutiny of All applications and selection of eligible beneficiaries as per selection criteria of the programme.
- b) Recommendation of admissible subsidy as per guidelines of the programme.
- c) Any other matter connected with the implementation of the programme.

III. Procedure for release of subsidy

1. Inviting of application through press release by Department of Fisheries for Municipal area and Tribal area and by respective Zilla Parishads of Rural areas of South Andaman and North & Middle Andaman.
2. Submission of Application in prescribed format to the Department of Fisheries / Zilla Parishad by the applicant of respective area.
3. Scrutiny of applications and selection of beneficiaries by the selection committee constituted for the purpose.
4. Intimation to the selected beneficiary for construction of new motorized / mechanized fishing boat.
5. Commencement of construction of boat by selected beneficiaries and intimation of the commencement of work to the concerned Zonal Fisheries Officer / Zilla Parishads.
6. Intimation for stage inspection at various stages by the beneficiary to the concerned Zonal Fisheries Officer / Zilla Parishads.
7. Conduct of stage inspection at various stages by the concerned Zonal Fisheries Officer / Zilla Parishads.
8. Submission of completion report of the boat along-with Seaworthiness Certificate, supporting bills, vouchers and duly signed agreement to the concerned Zonal Fisheries Officer / Zilla Parishads by the beneficiary.

9. Final Inspection by Fishing Boat Inspection & Assessment Committee and submission of report along-with Seaworthiness Certificate, supporting bills, vouchers and duly signed agreement, Registration Certificate of the boat under ReAL Craft along-with recommendation of the committee to the Directorate of Fisheries / Zilla Parishads.
10. Scrutiny of documents and recommendation of the Fishing Boat Inspection & Assessment Committee to Directorate of Fisheries / Zilla Parishad for release of admissible subsidy to the beneficiary or to the Financing Bank through DBT.

IV. Terms and Conditions for Construction / Purchase of Boat by selected beneficiary

1. The selected beneficiary shall construct the Fishing Boat as per approved drawing, design and technical specification provided by the Department of Fisheries.
2. The material to be used for construction of boat should be of superior quality and as per specifications i.e. by using superior quality of wood / marine grade FRP, engines and accessories as per specification.
3. No subsidy shall be admissible for purchase of any second hand Motorized or Mechanized Boat or use of old machinery / equipment / spares or any other material including wood for the construction of boat.
4. The construction of the boat should be undertaken from a reputed Boat Builder only.
5. The Boat shall also contain required number of Life Jackets and Life buoys of IRS / MMD Standards as per crew capacity of the Boat.
6. The Life Jackets & Life buoys shall be kept onboard the vessel at all times in good condition and to be produced during inspection at any time by the Fishery Officers failing which penalty shall be levied as per provisions of the A&N Marine Fishing Rules.
7. The selected beneficiary shall inform the commencement of the construction of boat with the name & address of the Boat Builder, Building Yard / Construction Site to the concerned Zonal Fisheries Officer / Zilla Parishads within 30 days from the date of his selection under the scheme.
8. The selected beneficiary shall inform the Department / Zilla Parishads for conducting stage inspection of the boat on completion of the following stages:-
 - a) 1st stage inspection – On lying of keel and fixing of ribs.
 - b) 2nd stage inspection – On fixing of frames, planks / hull.
 - c) 3rd stage inspection – On fixing of all equipments, painting / FRP coating, sheathing of hull, installation of engine, etc.

Note :- The stage inspection shall be carried out by the respective Zonal Officer (Deputy Director of Fisheries / Asst. Director of Fisheries) alongwith Officer Authorized by Chief Executive Officer, Zilla Parishad in case of beneficiaries from rural areas. During the inspection apart from physical inspection of the stage of construction the bills / documents towards the cost of materials used for the construction should be checked and recorded in the Inspection Report at every stage.

In the event of construction of boat by beneficiaries of rural areas, stage inspection shall be carried out by an Officer authorized by the Chief Executive Officer, Zilla Parishad, South Andaman / North & Middle Andaman for the purpose.

9. No deviation from the approved drawing, design and technical specification shall be allowed. However minor deviation on the overall length / breadth / depth shall be admissible on the recommendation of the Zonal Officer of the Department / Zilla Parishad based on Stage Inspection.
10. On completion of the construction of boat, the beneficiary shall obtain a seaworthiness certificate from a authorized Marine Engineer under the A&N Marine Fishing Rules and submit the same along-with supporting bills / vouchers from the boat Manufacturer / Builder towards the cost of material used for the Construction, Labour cost, cost of Engine etc. to the concerned Dy. Director of Fisheries / Asst. Director of Fisheries / CEO – Zilla Parishad.
11. On receipt of completion report from the beneficiary the respective Deputy Director of Fisheries / Asst. Director of Fisheries / Zilla Parishad shall arrange for final inspection and trial run of the boat. The final inspection and trial run of the boat constructed by beneficiaries shall be carried out by a "Fishing Boat Inspection & Assessment Committee" to be constituted by the Department comprising of the following:-
 - 1 Dy. Dir. of Fisheries / Asst. Dir. of Fisheries of – Member Convener
the concerned Zone / District
 - 2 Representative of Chief Executive Officer, – Member
South Andaman, North & Middle Andaman
 - 3 Representative of Deputy Commissioner, – Member

Nicobars
 - 4 Marine Mech. Engineer, Fishery Survey of – Member
India, Port Blair
 - 5 Representative of concerned Bank in the – Member
event of availing loan by the beneficiary.
 - 6 Junior Engineer (Mech.), Deptt. of Fisheries – Member
or any other Officer deputed for the work by
Director of Fisheries, A&N Islands.

V. Terms of reference of the Committee:-

1. The Committee shall scrutinize stage inspection reports of the boat during various stages conducted by the respective Deputy / Asst. Director of Fisheries.
2. The committee shall inspect the newly constructed Mechanized / Motorized boat, conduct trial run to ensure its conformity to the specifications prescribed by the Department and recommend the quantum of subsidy to be sanctioned.
3. Submission of Final Inspection Report to the Director of Fisheries / CEO – Zilla Parishad as the case may be.
4. The committee may co-opt Expert / Members including Naval Architect, CIFT or any other Govt. Department / autonomous body for expert opinion, if necessary.
5. The committee shall meet as and when required by the Department of Fisheries / Zilla Parishad. No TA / DA shall be paid by the Department / Zilla Parishads.
6. Any other remarks by the committee on the construction of the boat.
