The application with any claim/objection lacking the above required information will not be entertained and shall be summarily rejected.

No claims/objections will be entertained or accepted after the expiry of the stipulated date and time as specified above.

Further, the students who have applied for allotment of BDS, BAMS, BHMS, MBBS (Malayalee Origin), BAMS (Malayalee Origin) seats at mainland institutions are requested to submit the copy of score card of re-examination of NEET UG-2026 to the Development-IV Section (D-IV Section), Secretariat within 3 days after declaration of result for preparation of merit list.
