NOTIFICATION

No. A-12/5/2022-Home-Section-Sectt , In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No. U-14939/2/83-ANL dated 21st February, 1985, the Lt. Governor (Administrator), Andaman and Nicobar Islands hereby makes the following Amendment in the Recruitment Rules to the **Group -B (NG) post of Supervisor (Stores) (SI)** in the Police Radio Organisation of Andaman & Nicobar Police under Andaman and Nicobar Administration published in the Andaman & Nicobar Extraordinary Gazette notification No. 45 dated 28/01/2011.

Suggestions and objections are invited from the stakeholders/persons to be affected thereby. Suggestions and objection (if any), on these rules should reach the Office of the DGP, ANI within a period of 30 days of its publication in the Daily Telegram/Police Website/Notice Board of the DGP office for examination and consideration: -

1. Short title and commencement: -

- I. This Rules may be called the Andaman and Nicobar Administration, Police Department **Group 'B' (Non-Gazetted) post of Supervisor (Stores) (SI) in Andaman & Nicobar Police Radio Organisation, A&N Islands Recruitment (Amendment) Rules, 2025** .
- II. They shall come into force on the date of its publication in the Official Gazette

AMENDMENT

2. (i) The existing **Column - 05** of the **Schedule - VIII** appended to the Recruitment Rule shall be substituted as follows:-

(iii) The existing **Column - 12** of the **Schedule - VIII** appended to the Recruitment Rule shall be substituted as follows:

In case of recruitment by promotion / deputation / absorption grades from which promotion / deputation / absorption to be made	<u>Promotion:</u> From Storekeeper (ASI)/ Storeman Technical (ASI) in the Pay Matrix Level-6 (Rs. 35400 - 112400) with three years of regular service in the grade. <u>Note:</u> The eligibility list for promotion shall be prepared with reference to the date of completion by the officers of the prescribed qualifying service in Storekeeper (ASI)/Storeman Technical (ASI) (For determining seniority within the Police Radio Store Section, officers who were appointed initially — whether as Storekeeper or Storeman Technical— will be considered senior, regardless of their seniority in their parent units).
