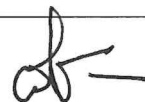

INSTRUCTIONS

1. Candidates must produce A-4 size colour printout of Admit Card (both sides) at the examination centre along with one of the following original valid photo identification proof documents, e.g., Passport, PAN Card, Aadhaar Card, Voter Identity Card, Aadhaar Card, Driving License (Along with a copy thereof) for entry and verification of identity.
2. Admittance to the examination centre and eligibility to sit in the examination is subject to verification of the identity, admit card and signature of the candidate. Mere sitting in the examination does not confer any right of selection.
3. To facilitate the verification of identity, candidates must report at the examination centre one (1) hour prior to the scheduled commencement of the examination.
4. Entry in the examination centre will be closed 45 minutes before the scheduled commencement of the examination. No candidate shall be allowed entry to the examination centre after closure of the entry.
5. Candidates are not permitted to carry personal calculators, electronic/smart watches, mobile phones or any other electronic/communication device(s) inside the examination hall. If any electronic gadget or objectionable item is found in the possession of any candidate, his/her candidature shall be cancelled without any further reference and the candidate shall also be subject to further legal actions. Candidates may be subjected to frisking to prevent carrying any prohibited item inside the examination hall.
6. Candidates shall be responsible for safekeeping of personal items brought by them.
7. Candidates shall be allowed to occupy their allotted seats 15 minutes prior to the scheduled start of the examination.
8. The Shorthand Booklet will be provided to the candidates 10 minutes prior to the scheduled start of the examination.
9. No candidate shall be permitted to the examination hall before the end of the examination and confirmation of due submission of the Transcription Script and Shorthand Booklet to the Invigilator.
10. Candidates must bring their own ball point pen (blue/black), pencil, eraser, sharpener, ruler etc. and these items will not be supplied at the examination centre.
11. The examination shall comprise of the dictation for 5 minutes, followed by 10 minutes time for correction by the candidates and thereafter, 20 minutes time shall be given for typewriting on computer (transcription).
12. Candidates must follow all the instructions carefully and accordingly fill up the requisite details in the spaces provided for the same. Any mistake on the part of the candidate shall be the candidate's own responsibility for which his/her candidature may be liable to be rejected.
