The list of eligible 18 (eighteen) candidates for undergoing trade test is annexed to this Notice as "Annexure-A".

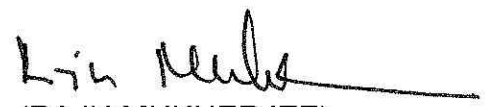

Candidates called for the examination (dictation and typewriting on computer) shall be required to appear at the examination venue on the date mentioned above at least 01 (one) hour prior to commencement of the examination at their own expenses and no T.A./D.A. shall be admissible to any of the candidates.

Candidates must bring A-4 size colour printout of Admit Card (both sides) and at least one original valid Photo Identity Proof documents, viz., Passport, PAN Card, Voter Identity Card, Aadhaar Card, Driving License (along with a photocopy thereof) to the examination venue for verification and in case of failure, candidate will not be allowed to appear at the examination.

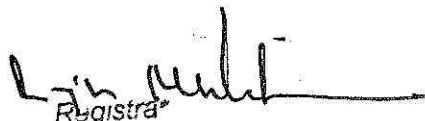
