1. INTRODUCTION

The Veterinary Council of India (VCI) is a statutory body established under an Act of Parliament viz Indian Veterinary Council (IVC) Act, 1984 under the Department of Animal Husbandry & Dairying, Government of India for regulation of veterinary practice, veterinary education and preparation and maintenance of Indian Veterinary Practitioner's Register.

VCI in exercise of the powers conferred by section 66(1) read with section 22(1) and section 21(1)(b) of the IVC Act, 1984 and in supersession of earlier Regulations with the previous approval of the Central Government framed VCI - Minimum Standards of Veterinary Education- (B.V.Sc.&A.H.) (MSVE) - Degree Course Regulations, 2016. As per Regulation 7(8) of VCI - MSVE - Degree Course (B.V.Sc. & A.H.) Regulations, 2016, 15% of the total seats allowed for admission in recognized veterinary colleges (included in First Schedule to the IVC Act, 1984) shall be filled by Veterinary Council of India on an all India basis through Common Entrance Exam.

In pursuance of letter No. K-12052-6/1/2017-LH-Part(1) (E-4741) dated 14th August, 2026 issued by the Department of Animal Husbandry Dairying and Ministry of Fisheries, Animal Husbandry and Dairying, Government of India, Veterinary Council of India will use qualified merit list of National Eligibility cum Entrance Test (NEET (UG)-2026) conducted by National Testing Agency (NTA) for filling up 15% seats in the recognized Veterinary Colleges under All India Quota during the Academic Session 2026-27. Other criteria of selection and admission to B.V.Sc. & A.H. Degree course shall be as per Veterinary Council of India - MSVE, Degree Course (B.V.Sc. & A.H.) Regulations, 2016. The schedule for the Counselling is Annexed. **(Annexure -1).**

2. DURATION OF THE COURSE

The duration of B.V.Sc. & A.H degree course is five and half years which includes compulsory Internship of one year period.

3. NUMBER OF SEATS FOR ADMISSION

Total 858 seats under 15% All India quota will be available for counselling / admission in the recognized Veterinary Colleges during 2026-27 (Details of seat matrix may be seen at **(Annexure- 2)**). The Seat matrix (College / Category wise will be uploaded on website www.vci.admissions.nic.in and www.vci.dahd.gov.in. The number of seats is subject to change for valid reasons if any, at any time, during the course of counselling.

4. ELIGIBILITY CRITERIA

4a. Nationality: Candidate should be Indian National.

4b. Overseas citizen of India / person of Indian origin

The Overseas Citizen of India (OCI) / Person with Indian Origin (PIO) also will be eligible for online registration for counseling for admission to B.V.Sc. &A.H. course under the 15% quota. However, such candidates shall have to produce sufficient proof and will be considered under general category for all purposes. The responsibility of the Veterinary Council of India in these cases will be limited to allocation of seats only. Fee and other conditions for OCI/PIO shall be applicable as per rules and regulations of respective University / College in this respect and candidate has to abide by such Rules/ Regulations of the University.

4c. Age

The candidate must have attained minimum age of 17 years as on 31st December, 2026.

4d. Essential Qualification

- (i) The candidates should have qualified NEET (UG) 2026.
- (ii) He / she should have passed the qualifying examination (10+2 or intermediate science) as defined under VCI - MSVE Regulations, 2016 with the subjects of Physics, Chemistry, Biology/ or Biotechnology and English (as a core course) and obtained marks as specified under regulations (7) of VCI MSVE Regulations, 2016 or have qualified in any of the examination equivalent to intermediate science examination of an Indian University or the Board recognized by the Association of Indian Universities ; taking Physics, Chemistry and Biology or Biotechnology including a practical test in each of these subjects and English.
- (iii) As per MSVE Regulations, 2016, the candidates under General category should have qualified in the subjects of English, Physics, Chemistry, Biology/ or Biotechnology, and have obtained minimum of 50% aggregate marks in the subjects in the qualifying examination. However, as specified by the Government from time to time the qualifying marks in the case of SC or ST or other special category of students will be 47.5% as per VCI- MSVE Regulations, 2016.
- (iv) The Admission of students to B.V.Sc.& AH degree course shall be on the basis of his or her merit and the ranking in the Merit list of NEET (UG) 2026 and subject to fulfilment of the other criteria as laid down above. No other merit or weightage shall be considered for admission to B.V.Sc.& AH degree course.

Note: At the time of admission to the College/University as may be allotted during the counselling:

1. The candidate having education in other countries/abroad, should produce a "Certificate from the Association of Indian Universities to the effect that the examination qualified by the candidate (in the subjects of Physics, Chemistry, Biology/Biotechnology and English) is equivalent to class 12th examination"
2. The Candidates whose final result / marks sheet is declared in grade points (CGPA/OGPA) at 12th Standard or equivalent examination, shall have to fill up the equivalent marks in the individual subjects (the marks obtained as well the corresponding maximum marks) while submitting On-line Registration Application Form. Further, the certificate of conversion formula, duly signed and issued by the concerned authority shall be produced at the time of admission.

4e. Physical Disability

Criteria for physical disability for admission to B.V.Sc. & A.H. course will be in accordance with the Right of Persons with Disabilities (RPwD) Act, 2016 and subsequent notification issued by the Ministry of Social Justice and Empowerment (MoSJE), Govt. of India on 12.03.2024 which underscores the principles of inclusive education and reasonable accommodation. PwD candidate must submit a valid UDID card issued by a designated medical Authority under MoSJE. For filling up seats under this quota for PwD candidate, a single uniform cut off shall be apply for all PwD candidates regardless of vertical category and same shall not lower than the, SC/ST cut off.

5. INSTRUCTION FOR REPORTING FOR ADMISSION

To Candidates:

- 1) The candidates who are allotted seat in the Counseling shall have to report to the respective College or the University as per date mentioned in the Schedule (Annexure-1). The candidates may contact the Nodal Officer of the respective College regarding admission/ reporting process.
- (2) Re-choice filling in respect of candidates who have been allotted seat in Round-1 for Round-2 shall be allowed only for those candidate who has physically reported at the College in time as per schedule dates. Further, in such cases, candidate has to inform the Nodal Officer of the reporting College about his/her willingness to participate in next Round of the Counselling. Candidate may also ensure that the Nodal Officer has made necessary entry/mark in the Counseling Portal about reporting/willingness to participate in next Round of Counselling. Authenticated proof for the same may be retained by the candidate.

- (3) In case the candidate fails to report to the allotted College within time, the allotted seat will be cancelled and same shall be allotted to other candidates. Such, candidates shall not be allowed for any further round of counselling.

For the University/College:

- (1) The Veterinary Colleges will nominate a NODAL OFFICER to facilitate and supervise the admission process of the candidates who will be allotted seats under 15% All India Quota. The Nodal Officers in term shall designate Reporting/Supporting Officer for the verification of the Admit Card, Original Certificates, Supporting Documents, fee details etc prior to admission of the candidates at the allotted College.
- (2) The VCI shall provide the user ID/Password to the Nodal officer on registered mobile number/e-mail.
- (3) On reporting of the candidates at the College in each Round, it will be the responsibility of the Nodal Officer to facilitate ease in the reporting process.
- (4) Further, in the event of candidates opting for re-choice filling in next Round, the Nodal Officer shall make necessary entries on the portal to the satisfaction of the candidates.

6. RESERVATION OF SEATS (under 15% All India Quota)

- (a) S.C.-15%
- (b) S.T.- 7.5%
- (c) E.W.S. - 10%
- (c) O.B.C. - 27% (Non Creamy Layer in Central List)

Candidates from creamy layer OBC and do not come under Central List of OBC are advised to mention his/her category as General.

- (d) PwD - 5% horizontal reservation

7. CONVERSION OF SEATS

In the event of non-availability of candidates under below mentioned categories, the conversation of seats for the allotment in Stray Round will be considered as per algorithms below:-

8. COUNSELING SCHEDULE AND IMPORTANT DATES

9. COUNSELING PROCEDURE

- (i) The online counselling for allotment of 15% seats to B.V.Sc & A.H. programme under VCI quota for the academic year 2026-27 will be held in three stages [Round -1, Round -2 and Stray Round] through NIC-Online-Counselling portal.
- (ii) The seat will be allotted in the colleges based on the availability of seats, his/her NEET Rank and the choice exercised by the candidates subject to fulfilment of other criteria viz. nationality, age, essential qualification etc. as laid down in this Information Bulletin.
- (iii) The seat allotment shall be only in respect of recognized Veterinary Colleges (both Government and Private) in India.
- (iv) The fees for admission in private Veterinary College will be as decided by the State Government or the University/College concerned and the Council shall not be responsible in this regard. **Hence, candidates are advised to confirm the details about the fees and other charges before exercising choices for the private Veterinary Colleges.** The Veterinary Council of India does not have any role with regard to fee structure of the Veterinary Colleges.
- (v) The eligibility criteria and the concerned documents of the candidate shall be verified by the allotted College/ University at the time of his / her reporting / admission and the decision of the college / university in the matter shall be final.
- (vi) The matter relating to academic session, tuition fee, other fees if any, may vary from College to College and shall be applicable as per rules and regulations of the respective College /University and the State Government.
- (vii) The candidate allotted seat in the first round of counselling and reports for admission within schedule dates will have an opportunity for up-gradation by exercising re-choice filling in the second round of counselling. In the case of seat allotted in Round – 2, the seat allotted earlier in Round – 1 will stand cancelled.
- (viii) For exercising of re-choice filling, the candidates need not have to pay the registration fee again in Round 2. However, those candidate who have not registered earlier in Round 1, may register in Round 2 by making payment of the registration fee.

- (ix) The candidate who have been allotted seat in Round -1 but not reported for admission to the allotted college shall not be allowed to participate in further round of counselling. Similarly, candidate who have been allotted seat in Round -2 but not reported for admission to the allotted college shall also not be allowed to participate in further round of counselling.

10. STRAY ROUND OF COUNSELLING (On-line)

- (i) STRAY ROUND COUNSELING will be conducted for allotment of vacant seats if any, after the completion of Round -2.
- (ii) The details of vacant seats available for Stray Round counseling will be notified on the VCI Counseling Portal. (Category wise)
- (iii) There will be no fresh Registration but all previously registered candidate who are interested for participation in STRAY Round shall pay fee of Rupees 50,000/- for General/OBC/EWS and Rs. 25,000/- for SC/ST/PH candidates respectively.
- (iv) **In the event of the candidate allotted seat in Stray Round and fails to report/take admission in the said College within the stipulated time, the Stray Round participation fee shall be forfeited by the Council and in this regard no correspondence under any circumstance shall be entertained and the candidate shall have no rights to claim the seat.**
- (v) The fee paid for appearing in Stray round will be refunded to the same account from which the amount has been received after completion of counselling [Academic year 2026-27]
- (vi) The Stray Round fees shall be refunded to all such candidates who are not allotted any seat and those who have reported and taken admission against the allotted seats in this round within the specified time.
- (vii) The candidates who are allotted seats (reported or not reported to respective college) will **not be eligible** to participate for Stray Round admission.
- (viii) Vacant seats as may be available will be allotted based on the **Merit and Option** of the candidates under respective category of the candidate.
- (ix) Candidate can exercise option entry as per their choices and seat availability.
- (x) Candidates who are allotted seats in Stray Round will be issued auto generated Allotment Letter and they will report at the respective college as per schedule time.
- (xi) Available vacant seats and the list of eligible candidates to appear in Stray Round of Counseling will be notified on VCI Counseling Portal as per Counseling Schedule [Annexure -1]

- (xii) The aspirant candidates for participating in Stray Round of Counselling may seek necessary information [viz Fee structure, Mode of Payment to be made the College etc] from the Nodal officer of the listed Colleges prior to giving choices of colleges for the stray round on the portal.
- (xiii) In the event of candidates allotted seat in Stray Round of Counselling and failing to report at the respective College as per schedule (Annexure -1) the fee paid [Stray round fee] shall be forfeited.
- (xiv) **The candidates are advised to confirm the details about the fees and other charges before exercising choices for the private Veterinary Colleges and the Council shall not entertain any request for change of college.**

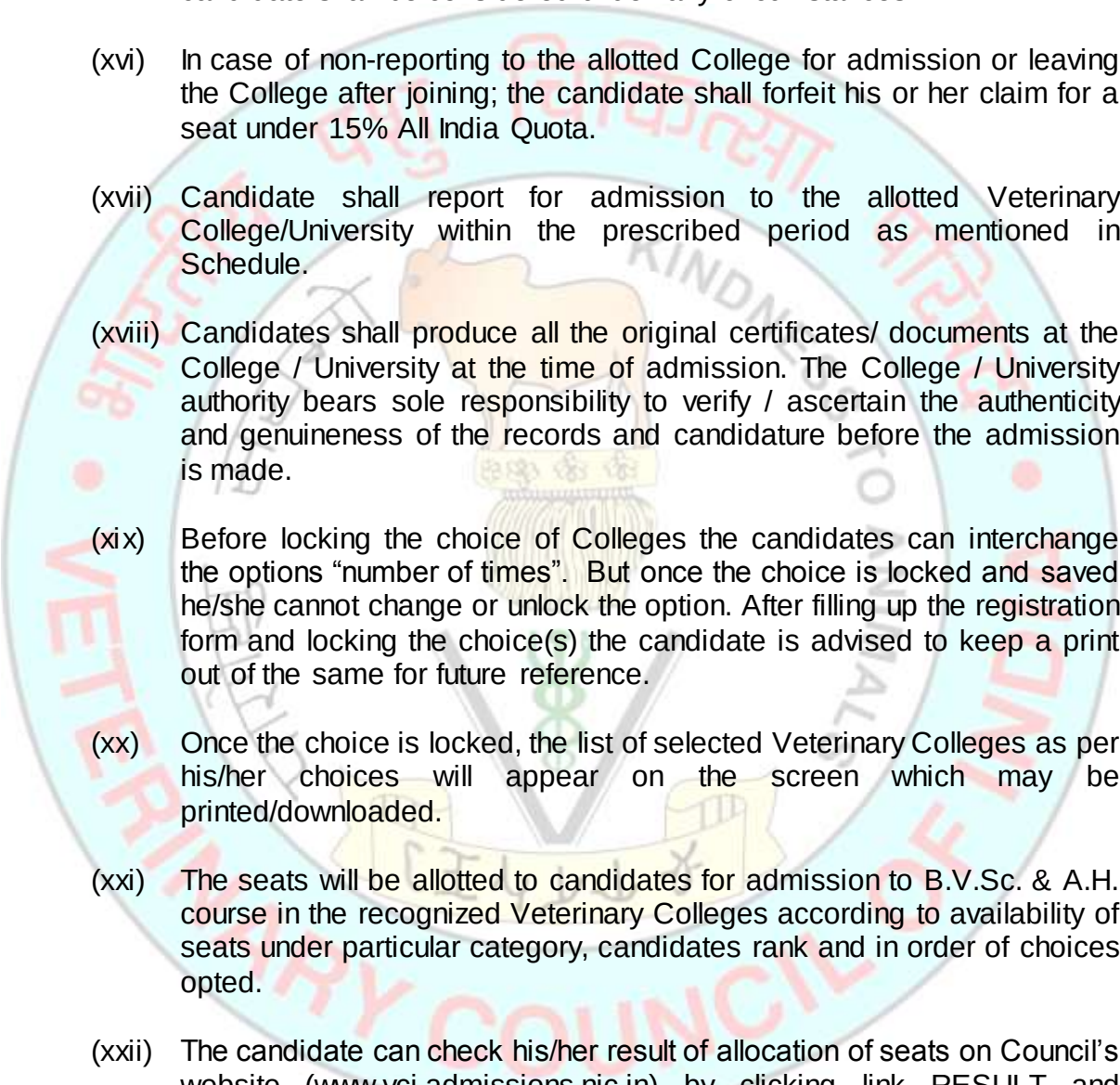
- (i) The payment of Registration fee /participation fees for stray round shall be made only through Net banking/Debit/Credit Card. **(Other mode of payments viz. cash, Cheque, Demand Draft, Wallet Payment of Digital Platform (like Paytm, Phonpe, Google Pay, Mobikwik, ICICI Pockets, Airtel Payment bank wallet, Jio Payment bank wallet etc), NEFT/RGTS etc are not allowed).**
- (ii) It will be the sole responsibility of the candidate to make payments in time and ensure about the transfer of fund to the dedicated account. VCI will not be responsible in any manner for non-receipt of fees.
- (iii) Similarly, in the event of non-receipt of Stray Round Participation Fee such candidates shall not be considered for allocation of seats under Stray round.

13. IMPERSONATION

The online self-declaration of the candidate and other documents will be verified at the time of admission by the allotted University/College authorities and if found to be false at any time, the candidature/admission of such candidate shall be cancelled and the criminal proceedings as deemed fit may be initiated by the authorities of the concerned University/College.

14. IMPORTANT INSTRUCTIONS

- (i) **The candidates are advised that e-mail address and mobile number provided in the online application form of NTA for NEET (UG-2026) is used for Registration on the VCI portal for counseling.**
- (ii) Veterinary Council of India does not allot any seat either on nomination basis or manually.
- (iii) Candidates are advised to go through the Information Bulletin before Registration on VCI counselling portal.
- (iv) Changes if any, in the registered mobile number or e-mail address mentioned with NTA will be at the responsibility of the candidates.
- (v) Qualified and eligible candidates are required to register on the VCI website (www.vci.admissions.nic.in) to participate in the Counseling process for allotment of seats.
- (vi) The allotment of seats shall be made through online as per detail schedule given on the Council's website (www.vci.admissions.nic.in).
- (vii) No separate intimation regarding counselling will be sent to the candidates individually.
- (viii) The candidates are advised to visit Council's website (www.vci.admissions.nic.in) regularly for latest instructions.
- (ix) Counselling/allotment of seats will be held as per the Category Rank (UR/SC/ST/OBC/EWS/URPH/OBCPH/EWSPH/SCPH/STPH).
- (x) The allotment of seat shall be made on the basis of merit Rank in NEET (UG) 2026; subject to fulfilment of other criteria as laid down and availability of seats in particular Veterinary College.
- (xi) The Allotment/Counselling of OBC candidates (creamy layer) shall be done along with the candidates of Unreserved (UR) category i.e. Unreserved + OBC category candidates (creamy layer) shall be considered together as per their category rank only.
- (xii) Mere registration for counselling on the website of the Council shall not automatically guarantee any seat for admission to B.V.Sc. & A.H. course under 15% All India quota.
- (xiii) The candidate who fails to register his/her name and make payment of fee for Counselling on the Council's website (www.vci.admissions.nic.in) within the stipulated time shall not be eligible for allotment of seat and he/she shall have no rights to claim for a seat under All India Quota.

- 
- (xiv) Fee structures are regulated by the concerned State Governments/ Universities/Veterinary Colleges and VCI has no role in this regard. Therefore, the candidates may consult concerned Universities / Veterinary Colleges with regard to fee structure before exercising options under 15% All India quota.
- (xv) The candidate who fails to report to the allotted college/University as per scheduled time shall lose his/her seat and thereafter no claim by the candidate shall be considered under any circumstances.
- (xvi) In case of non-reporting to the allotted College for admission or leaving the College after joining; the candidate shall forfeit his or her claim for a seat under 15% All India Quota.
- (xvii) Candidate shall report for admission to the allotted Veterinary College/University within the prescribed period as mentioned in Schedule.
- (xviii) Candidates shall produce all the original certificates/ documents at the College / University at the time of admission. The College / University authority bears sole responsibility to verify / ascertain the authenticity and genuineness of the records and candidature before the admission is made.
- (xix) Before locking the choice of Colleges the candidates can interchange the options "number of times". But once the choice is locked and saved he/she cannot change or unlock the option. After filling up the registration form and locking the choice(s) the candidate is advised to keep a print out of the same for future reference.
- (xx) Once the choice is locked, the list of selected Veterinary Colleges as per his/her choices will appear on the screen which may be printed/downloaded.
- (xxi) The seats will be allotted to candidates for admission to B.V.Sc. & A.H. course in the recognized Veterinary Colleges according to availability of seats under particular category, candidates rank and in order of choices opted.

- (xxv) The candidates or their relatives visiting VCI, New Delhi for seeking change of the allotment would face disqualification and such visits would be treated as trespassing. Adopting unfair means at any stage shall be disqualified for counselling and allotment of seat for admissions.
