**NOTIFICATION**

No .42-716/2026-SH in exercise of the power conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No. 14/3/60-ANL dated 11/04/1960, and in pursuance of DOPT's OM No .AB. 14017/13/ 2016-Estt(RR) dated 09.08.2016, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands hereby makes the following amendment to the recruitment Rules to **Group - C (Non-Gazetted), Non-Ministerial** post of **Assistant Light Keeper** of Department Port Management Board, Andaman & Nicobar Administration published in the A & N Extraordinary Gazette Notification No.329/2011/F.No.42-716/2010-TR dated 22.12.2011.

**1. SHORT TITLE AND COMMENCEMENT:**
