No.SH. in exercise of the power conferred by the proviso to Article 309 of the Constitution of India, read with the Government of India, Ministry of Home Affairs, New Delhi, Notification No. 14/3/60-ANL dated 11/04/1960, and in pursuance of DOPT's OM No .AB. 14017/13/ 2016-Estt(RR) dated 09.08.2016, the Lieutenant Governor (Administrator), Andaman & Nicobar Islands hereby makes the following amendment in the recruitment Rules to **Group - C (Non-Gazetted), Non-Ministerial post of Commercial Accountant** in the Department Port Management Board, Andaman & Nicobar Administration published in the A & N Extraordinary Gazette Notification No.69/91-F.No.42-223/90-TR dated 13.06.1991.

Suggestions and objections are invited from the stakeholders/ persons to be affected thereby, Suggestions and objections (if any), on these rules should reach the Office of the Port Management Board within 30 days of its publication in the Daily Telegram/ Notice Board of the PMB office for examination and consideration:

1. SHORT TITLE AND COMMENCEMENT:

- i. This Rule may be called the Andaman and Nicobar Administration, Port Management Board, **Group-C (Non-Gazetted), Non-Ministerial post of Commercial Accountant** Recruitment (Amendment) Rules, 2026.
- ii. They shall come into force on the date of its publication in the Official Gazette.

AMENDMENTS

Higher Grade Clerk of AC Cadre with 08 years regular service in the grade with sufficient knowledge in proforma accounts etc.
