Any person having objections, claims, or relevant information with respect to any vessel included in the list may submit a representation, along with supporting documents, to the Zonal Fisheries Office, South Andaman, within 10(Ten) days from the date of publication of this notice.

All concerned are requested to carefully examine the published list and submit their objections, claims, or relevant information, if any, within the prescribed period. No representation received after the expiry of the stipulated period shall be entertained.

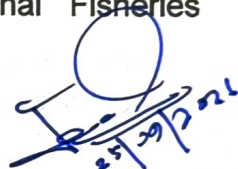
